More Hope Than Despair for Economic Recovery

For the past decade, there has been turbulence in our business environment.

This has manifested itself in mergers, dissolutions, downsizings and the dreaded departures. But there are macro indications of recovery, such as employment levels. But seldom do we find employees or employers in Delaware who feel "recovered." That is probably because of anemic wage growth, the lack of annual announcements of new mega-employers and the persistence of shootings in our most central city.

If there is anything to be learned from Delaware history, it is that nothing stays the same. As much comfort as it brings to hold onto the relics of the past, life seems to bring us surprises. From the shape of our coastline, to the key industries that were the bedrock of our upbringing, everything changes. But equally notable in Delaware history is how Delawareans don't "go gently into that good night" when they begin to see the dying lights of prosperity.

In 2016, the topic of economic development has spurred conversations in classrooms, lunchrooms and boardrooms. I think we should find hope in the following examples of groups taking the conversation into action with creative visions for the sake of our economic future.

For instance – the Reinventing Delaware Program – which is a by-product of the Pete du Pont Freedom Award Foundation. Without any motive other than to create a better landscape for employment, over thirty knowledgeable volunteers are focused on two primary initiatives. First, they have an idea to create "Silicon Valley East" whereby Delaware would become a hub for technology and sciences, much like Silicon Valley in California. They are also working to develop the Arden Plan. This plan hopes to completely eliminate the personal income tax, corporate income tax, gross receipts tax, and the estate and inheritance taxes. This revenue can be replaced by establishing one flat tax of 1.4 percent on all Delaware property.

Another great example includes the Committee of 100, a 50-year-old advocacy group for economic development. They have formed a working relationship with the city of Wilmington to offer the private sector perspective regarding ways to attract private investment. The issues identified run the gamut from the need for a clearly enunciated neighborhood revitalization strategy, to city staff qualifications and attitude, to significant reforms in the city's permitting process, to public safety perceptions, to targeted tax incentives, to visible demonstrations of policy changes in the form of public space and transportation corridor improvements. EDiS has been involved with a working group that has been creating a list of detrimental policies and procedures within L&I that create incentives for developers to choose other municipalities over Wilmington...
