GreenNCC

The Committee of 100 organized a presentation earlier this month by New Castle County Executive Matt Meyer, and Land Use Manager Rich Hall and his staff on three of the county's proposed GreenNCC initiatives.

Members of our Land Use and Environment & Energy Committees, along with experts from DCA and ACEC, shared concerns with what was being proposed and the potential impact on development project costs and timelines. The group made suggestions that county officials will consider as they draft proposed ordinances on Private Community Open Space, Forest Conservation and Stormwater/Drainage.

Forest conservation and stormwater/drainage requirements generated the most concerns and will warrant further discussion, especially as they impact Ready in 6 goals. The Committee of 100 and DCA are working with other stakeholders statewide to identify responsible ways to reduce permitting times and costs through the Ready in 6 campaign.

Following our meeting, the Department of Land Use issued a status report. Feedback is being used to further inform development of draft legislation on these three issues. [Read the full update here.](#)
